1) QUOTATIONS (per the accompanying group quotation and itinerary)

Prices are based on current rates of exchange and Catholic Travel Centre (hereafter referred to as CTC) reserves the right to re-quote if the exchange rates fluctuate. Individual deviations from the tour's scheduled itinerary will be quoted and charged separately upon request, are permitted only on the return portion of the trip, and are limited to two persons per tour (see 'Deviations' below).

TRAVEL WARNING: This is to inform you that there is a Travel Warning issued by the Department of State for travel to Israel, the West Bank and Gaza. This warning might still be in effect on the day of your travel and your cancellation for this reason does not constitute grounds for refund of the cancellation fees listed below.

2) GROUP TOUR DEPOSITS

a. Tour Initiation Deposit: All travel arrangements will be initiated upon receipt of a \$500 Tour Initiation Deposit and a signed copy of these Terms and Conditions, confirming your acceptance of our itinerary and pricing as quoted. Both items must be received within 14 days of quotation otherwise quotation will be subject to revision. Note that no airline or hotel reservations have been made at this time and quoted prices are subject to change if dates selected do not allow bookings to be made at quoted prices.

If the tour is cancelled 150 days or more prior to departure, a fee of \$250 will be assessed to cover CTC's administrative expenses. In addition, you will be assessed the cost of printing the promotional brochures (if applicable), up to the full value of the \$500 initiation deposit; if the tour is cancelled fewer than 150 days prior to departure, the whole Tour Initiation Deposit is forfeited. If the tour travels with the minimum group size, the Tour Initiation Deposit will be refunded. CTC reserves the right, at its sole discretion, to cancel the tour if it does not reach the minimum group size shown in the attached quotation by 90 days prior to departure and to apply the above stated costs to the Tour Initiation Deposit.

b. Additional Deposits for the Group Reservation: Deposits other than the Tour Initiation Deposit may occasionally be required according to a particular supplier's policy. If a lodging, airline or other supplier requests such a deposit, you will be responsible for this deposit and will be advised in writing of the amount of the deposit and its cancellations terms.

3) INDIVIDUAL REGISTRATION: Participants must send an original copy of the completed registration form along with a deposit of \$300 per person to register for the tour. Final payment from each registrant must be received by CTC at least 60 days prior to departure. CTC reserves the right to release all airline and hotel space for which the \$300 deposit and individual registration have not been received at least 90 days prior to departure.

4) INDIVIDUAL CANCELLATION: (all cancellations must be received in writing, signed and dated, by certified mail or by fax)
